

MUNICIPALITY OF CROWSNEST PASS

BYLAW 927, 2015

A BYLAW OF THE MUNICIPALITY OF CROWSNEST PASS FOR THE PURPOSE OF CLOSING TO PUBLIC TRAVEL AND CREATING TITLE TO AND DISPOSING OF PORTIONS OF A PUBLIC HIGHWAY IN ACCORDANCE WITH SECTION 22 OF THE MUNICIPAL GOVERNMENT ACT, CHAPTER M26, REVISED STATUTES OF ALBERTA 2000, AS AMENDED.

WHEREAS, the lands hereafter described are no longer required for public travel,

WHEREAS, application has been made to Council to have the roadway closed, and

WHEREAS, the Council of the MUNICIPALITY OF CROWSNEST PASS deems it expedient to provide for a bylaw for the purpose of closing to public travel certain roads or portions thereof, situated in the said municipality and thereafter creating title to and disposing of same, and

WHEREAS, notice of intention of Council to pass a bylaw has been given in accordance with Section 606 of the Municipal Government Act, and

WHEREAS, Council was not petitioned for an opportunity to be heard by any person claiming to be prejudicially affected by the bylaw

NOW THEREFORE BE IT RESOLVED that the Council of the MUNICIPALITY OF CROWSNEST PASS in the Province of Alberta does hereby close to Public Travel and creating title to and disposing of the following described highways, subject to rights of access granted by other legislation.

ALL THAT PORTION OF 78TH STREET BETWEEN 18TH AVENUE AND 19TH AVENUE, AND THAT PORTION OF THE ALLEY WHICH LIES BETWEEN LOTS 1 TO 3, AND LOTS 11 TO 13 IN BLOCK 18, AND ALL OF THE ALLEY IN BLOCK 19, CONTAINING 0.161 HECTARES (0.40 ACRES) MORE OR LESS, EXCEPTING THEREOUT ALL MINES AND MINERALS AS SHOWN IN RED ON ATTACHED "SCHEDULE A".
