- (b) Make the font type for the year smaller than the font type for the building name.
- (c) Epoxy will likely be the material to be used add the colours to the Municipal logo.
- (d) Add a space where a QR code and the Municipal website address can be added on a decal or sticker, which is replaceable if necessary. The QR code will lead to the Municipal website where a person may read more about the history of the building, its character defining elements, and why it was designated as a historic resource.
- (e) Johan van der Bank mentioned that Kim Uhersky said that the plaque design is scalable, and therefore its dimensions can be made whatever the Advisory Committee determines as the appropriate size.
