

MUNICIPALITY OF CROWSNEST PASS

BY-LAW NO. 779, 2009

A By-law of the Municipality of the Crowsnest Pass, in the Province of Alberta, to amend Schedule “A” (a tariff for sewer rates) of Bylaw No. 579, 2002, a bylaw of the Municipality of Crowsnest Pass, in the Province of Alberta, RESPECTING A SEWAGE SERVICE CHARGE AND REGULATING THE DISPOSAL OF SEWAGE AND THE DISCHARGE OF LIQUIDS AND WASTE INTO THE MUNICIPAL SEWERAGE SYSTEM.

The Council of the Municipality of Crowsnest Pass, in the Province of Alberta, duly assembled, hereby enacts as follows:

That SCHEDULE “A” of Bylaw No. 579, 2002 be amended as follows:

SCHEDULE "A" FEES

The fees for Sewer Services shall be **SEVENTY-THREE (73%) PERCENT** of the fee charged for Water Services plus a flat fee of 1.45 per month per account.
